A minimum purchase or registration is not required other than your resale tax permit copy.

California destination merchandise taxable at 7.25% without a valid sales permit on file.

All dropship orders are self-service and must be placed online

We accept payment through Visa, MasterCard, Discover, American Express and PayPal.

We do not offer terms.

How to Place Dropship Orders

Once you receive an order, simply place your dropship order at KoehlerHomeDecor.com. Your order will ship directly to your customer; however, correct billing information is required to prevent your order from being rejected.

Type your customers shipping information in the shipping fields and your billing information in the billing fields. Receipts and tracking information will be received at the email address used at order placement so be sure to use your email address and not your order recipient.

To include your company name on the shipping label, type your name in the "Company" field in the shipping information.

If you have not submitted your sales tax permit document your order will maintain the sales tax charge. If you have submitted valid sales tax documentation you will not be charged sales tax. Applies to California destination merchandise only.

Your order is not complete until you click "send order" and receive a confirmation page.

Tracking numbers will be emailed to you in 1-2 business days and uploaded to your account if registered.

Sales Tax Liability

States with no sales tax shipping resale products into California require proof of your Federal EIN number to honor your non-taxable sales - applies to Alaska, Delaware, Montana, New Hampshire, Oregon and foreign purchasers.

Amazon FBA Requirements:

Koehler Home Décor ships to Amazon warehouses.

A minimum purchase of \$100.00 in merchandise is required.

If you wish to supply pre-paid labels you must order by the case quantity.

If you do not wish to supply prepaid labels, we can ship directly for the freight charge charged when you placed your order. Ordering case quantity is not required.
